**Resolution No. 2023- 165**

**A RESOLUTION OF NO OBJECTION AND GIVE PERMISSION TO THE KIT PROPERTIES, INC., REPRESENTED BY ITS PRESIDENT, KIM DENNIS M. GO, AND ITS CONSORTIUM TO CONDUCT RESEARCH, EXPLORATION AND ASSESSMENT IN THE BARANGAYS OF OPOL, MISAMIS ORIENTAL AND TO DEVELOP AND OPERATE A BULK WATER SUPPLY PROJECT AND WATER DISTRIBUTION UTILITY IN THE MUNICIPALITY OF OPOL, INCLUDING THE CONSTRUCTION OF THE NECESSARY INFRASTRUCTURE THEREFOR**

**WHEREAS**, Section 16 (a) of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code likewise provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

**WHEREAS**, pursuant to 17 (b) (2) (viii) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated May 26, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution of No Objection and give permission to the Kit Properties, Inc., represented by its President,



Kim Dennis M. Go, and its consortium to conduct Research, Exploration and Assessment in the barangays of Opol, Misamis Oriental and to develop and operate a Bulk Water Supply Project and Water Distribution Utility in the Municipality of Opol, including the construction of the necessary infrastructure therein;

**WHEREAS**, the water supply in Opol, Misamis Oriental is always the top concern for decades. The scarcity of water supply in the municipality is a hindrance for the local government unit to provide its constituents easy access to safe, sufficient and sustainable water supply and sanitation;

**WHEREFORE**, in a motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Palmero F. Ebonia; it was


