**Resolution No. 2023- 166**

**A RESOLUTION APPROVING AND ENDORSING THE GABALDON BUILDING, SITUATED AT OPOL CENTRAL SCHOOL, AS A CULTURAL HERITAGE PRESERVATION SITE OF THE MUNICIPALITY OF OPOL**

**WHEREAS**, the State shall foster the preservation, enrichment, and dynamic evolution of a Filipino national culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression. It shall also shall conserve, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations<sup>1</sup>;

**WHEREAS**, Section 16 (a) of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code likewise provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to the Code;

**WHEREAS**, in an urgent letter dated May 24, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution Approving and Endorsing the Gabaldon Building located at Opol Central School, Poblacion, Opol, Misamis Oriental as a Cultural Heritage Preservation Site of the Municipality of Opol;

**WHEREAS**, the Gabaldon Building stands as a treasured cultural heritage in the Municipality of Opol, and serves a testament of the past and embodies cherished memories that profoundly connect to our roots for the present generations;

**WHEREFORE**, in a motion presented by Hon. Rhally Mae G. Piit, and duly seconded by Hon. Jeffrey P. Pusan; it was

**RESOLVED, AS THE BODY HEREBY RESOLVES**, to approve the Resolution Approving and Endorsing the Gabaldon Building, situated at Opol Central School, as a Cultural Heritage Preservation Site of the Municipality of Opol.


