**Resolution No. 2023- 167**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES (LBP), REPRESENTED BY ITS PRESIDENT AND CEO, CECILIA C. BORROMEO, THROUGH ITS ASSISTANT VICE PRESIDENT, LIGAYA D. PADILLA OF LBP-CAPISTRANO BRANCH, FOR THE ADOPTION AND USE OF LINK.BIZPORTAL AS A DIGITAL PAYMENT PLATFORM FOR LGU TRANSACTIONS**

**WHEREAS**, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code mandates that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated May 24, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him enter into a Memorandum of Agreement (MOA) with the Land Bank of the Philippines (LBP), represented by its President and CEO, Cecilia C. Borromeo, through its Assistant Vice President, Ligaya D. Padilla of LBP-Capistrano Branch, for the adoption and use of Link.BizPortal as a digital payment platform for transactions of the local government unit;

**WHEREAS**, Link.BizPortal is an e-Payment facility that allows clients to pay for products and services through the Internet from both the government and private institutions and sectors;

**WHEREFORE**, in a motion presented by Hon. Rhally Mae G. Piit, and duly seconded by Hon. Jeffrey P. Puasan; it was


