**Resolution No. 2023- 168**

**A RESOLUTION DECLARING AS OPERATIVE BARANGAY APPROPRIATION ORDINANCE NO. 01, SERIES OF 2023 OF BARANGAY IGPIT, OPOL, MISAMIS ORIENTAL ENTITLED "AN ORDINANCE REALIGNING THE AMOUNT OF PHP150,000.00 FROM MULTI-PURPOSE REHABILITATION AND PHP200,000.00 FROM ROAD REHABILITATION FOR A TOTAL OF PHP350,000.00 TO CONSTRUCTION OF LINE CANAL"**

**WHEREAS**, the Barangay Igpit of Opol, Misamis Oriental has submitted the Barangay Appropriation Ordinance No. 01, Series of 2023 to the Sangguniang Bayan of Opol for review;

**WHEREAS**, Barangay Appropriation Ordinance No. 01, Series of 2023 realigns the amount of One Hundred Fifty Thousand Pesos (PhP150,000.00) from the Multi-Purpose Building Rehabilitation and Two Hundred Thousand Pesos (PhP200,000.00) from the Road Rehabilitation to the Construction of Line Canal with a total amount of Three Hundred Fifty Thousand Pesos (PhP350,000.00) all under the 20% Barangay Development Fund;

**WHEREAS**, Section 316 (f) of the Local Government Code states that the Local Finance Committee shall assist the sangguniang panlalawigan in the review and evaluation of budget of component cities and municipalities in the case of provincial finance committee, the barangay budgets in the case of city or municipal finance committee, and recommend the appropriate action thereon;

**WHEREAS**, Section 447 (a) (1) (i) of the Local Government Code mandates the Sangguniang Bayan to approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and to review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

**WHEREAS**, the Local Finance Committee, through the Municipal Budget Officer, has reviewed Barangay Appropriation Ordinance No. 01, Series of 2023 and found it to be within the scope of the prescribed powers of the Sangguniang Barangay of Igpit, Opol, Misamis Oriental, subject however, to the condition in its Letter dated May 5, 2023, stating that all disbursements of the item specified are subject to the conditions of all accounting and auditing rules and regulations and to the availability of funds;

**WHEREAS**, the Committee on Finance, Budget and Appropriation has recommended the approval of the Barangay Appropriation Ordinance No. 01, Series of 2023 of Barangay Igpit, Opol, Misamis Oriental;

**WHEREAS**, the Sangguniang Bayan concurs with the findings and recommendations of the Committee;

**WHEREFORE**, in a motion of Hon. Danilo O. Daroy and duly seconded by Hon. Roland B. Alfeche; it was


