Resolution No. 2023- 168-A

A RESOLUTION GIVING CASH INCENTIVES TO MS. JUDILYN ABANG LUMAJANG OF OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)

WHEREAS, Section 17, Article II of the 1987 Constitution provides that the State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, under the Philippine Teachers Professionalization Act of 1994, also known as Republic Act No. 7836, it is a requirement for all applicants for a license to pass the Licensure Examination for Teachers (LET) conducted by the Board for Professional Teachers of the Professional Regulation Commission;

WHEREAS, the Professional Regulation Commission with the Professional Regulatory Board for Professional Teachers conducted the Licensure Examination for Teachers last March 19, 2023 in at least thirty-seven (37) testing centers nationwide;

WHEREAS, a total of 24,819 elementary teachers out of 60,896 examinees (40.76%) and 48,005 secondary teachers out of 102,272 examinees (46.94%) passed the March 2023 LET;

WHEREAS, Ms. Judilyn Abang Lumajang of Opol, Misamis Oriental, landed in the Top Six (6) of the recently concluded LET, Elementary Level;

WHEREAS, Ms. Judilyn Abang Lumajang garnered 91.20% of the abovementioned examination;

WHEREAS, this accomplishment obtained by Judilyn Abang Lumajang has brought tremendous pride and honor to the Municipality of Opol as it inspires students from Opol and around the country to aspire for excellence through diligent study, hard work, and perseverance;

WHEREAS, by recognizing the hard-earned achievement of the topnotcher from the Municipality of Opol, we promote a culture of excellence in the Municipality by giving credit and honor where these are due;

WHEREAS, in consideration of the foregoing, the Sangguniang Bayan of Opol congratulates and commends Ms. Judilyn Abang Lumajang and gives her cash incentives in the amount of Ten Thousand Pesos (PhP10,000.00) which shall be funded out of the general funds;




WHEREFORE, in a motion presented by Hon. Rhally Mae G. Piit, and duly seconded by Hon. Palmero F. Ebonia; it was


