Resolution No. 2023- 170

A RESOLUTION APPROVING THE COMMITTEE MEMBERSHIP OF THE REGULAR AND STANDING COMMITTEES OF THE SANGGUNIANG BAYAN OF OPOL

WHEREAS, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 50 (b) (1) of the Code provides that the rules of procedure shall provide for the organization of the sanggunian and the election of its officers as well as the creation of standing committees which shall include, but shall not be limited to, the committees on appropriations, women and family, human rights, youth and sports development, environmental protection, and cooperatives; the general jurisdiction of each committee; and the election of the chairman and members of each committee;

WHEREAS, Section 2 (b), Rule XI of the Omnibus Rules of Procedure of the Twenty-First (21st) Sangguniang Bayan of the Municipality of Opol Year 2022-2025 states that the Presiding Officer may recommend the creation or reorganization of any regular or standing committee. The Sanggunian shall act on his recommendation without debate and vote on it immediately;


