**Resolution No. 2023- 171**

**A RESOLUTION REQUESTING THE REGIONAL OFFICE OF THE DEPARTMENT OF SCIENCE AND TECHNOLOGY 10, THROUGH ITS REGIONAL DIRECTOR, DIRECTOR ROMELA N. RATILLA, TO FUND THE PURCHASE OF EQUIPMENT FOR SOLID WASTE MANAGEMENT FOR THE MUNICIPALITY OF OPOL**

**WHEREAS**, Section 16 (a) of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code likewise provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

**WHEREAS**, pursuant to 17 (b) (2) (vii) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, solid waste disposal system or environmental management system and services or facilities related to general hygiene and sanitation;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated June 2, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution requesting the Department of Science and Technology (DOST) – Regional Office 10, through its Regional Director, Director Romela N. Ratilla, to fund the purchase of equipment/machineries for the Solid Waste Management of the Municipality of Opol;

**WHEREAS**, the following items are the identified machineries that can address the solid waste problems in the municipality:

- a) Pulverizer Machine;
- b) Bottle/Glass Pulverizer "B";
- c) Plastic Extruder Machine;
- d) Baler Machine;
- e) Multipurpose Heavy Duty Biodegradable Shredder Machine;
- f) Plastic Densifier Machine;



- g) Plastic Shredder Machine; and
- h) Pyrolysis Machine.

**WHEREFORE**, in a motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Palmero F. Ebonia; it was


