Resolution No. 2023- 172

A RESOLUTION REQUESTING FUNDS FROM THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), THROUGH ITS DEPARTMENT SECRETARY, SECRETARY AMENAH F. PANGANDAMAN, FOR THE INSTALLATION OF SOLAR-POWERED STREET LIGHTS ALONG BARANGAY TABOC, OPOL, MISAMIS ORIENTAL AMOUNTING TO FIFTY MILLION PESOS (PHP50,000,000.00)

WHEREAS, Section 16 (a) of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code likewise provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

WHEREAS, pursuant to 17 (b) (2) (viii) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities;

WHEREAS, Section 444 (b) (1) (vi) of the Code states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated June 1, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution requesting funds from the Department of Budget and Management (DBM), through its Department Secretary, Secretary Amenah F. Pangandaman, for the Installation of Solar-Powered Street Lights in Barangay Taboc, Opol, Misamis Oriental amounting to Fifty Million Pesos (Php50,000,000.00);



WHEREFORE, in a motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Palmero F. Ebonia; it was


