**Resolution No. 2023- 173**

**A RESOLUTION REQUESTING FUNDS FROM THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), THROUGH ITS DEPARTMENT SECRETARY, SECRETARY AMENAH F. PANGANDAMAN, FOR THE CONSTRUCTION OF FARM-TO-MARKET ROAD IN BARANGAY TABOC, OPOL, MISAMIS ORIENTAL AMOUNTING TO FIFTY MILLION PESOS (PHP50,000,000.00)**

**WHEREAS**, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the same Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein;

**WHEREAS**, pursuant to Section 444 (b) (4) (i) of the Code, the local government unit, through the municipal mayor, shall ensure the delivery of basic services and the provision of adequate facilities as provided for under Section 17 of the Code and, in addition thereto, shall ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the municipality and the province;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code likewise states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated June 5, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution requesting funds from the Department of Budget and Management (DBM), through its Department Secretary, Secretary Amenah F. Pangandaman, for the Construction of Farm-To-Market Road in Barangay Taboc, Opol, Misamis Oriental amounting to Fifty Million Pesos (Php50,000,000.00);



**WHEREAS**, the rural road project will enable connectivity and safe, fast and dependable mobility among commuters and motorists and provides positive impact because it will give easy access to health, education and economic opportunities among Micro, Small and Medium Enterprises (MSMEs) and small hold farmers;


**WHEREFORE**, in a motion presented by Hon. Danilo O. Daroy and duly seconded by Hon. Palmero F. Ebonia; it was
