Resolution No. 2023- 174

A RESOLUTION DECLARING AS VALID BARANGAY ORDINANCE NO. 01, SERIES OF 2023, OF BARANGAY LUYONGBONBON, OPOL, MISAMIS ORIENTAL ENTITLED "AN ORDINANCE ON COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS"

WHEREAS, the Barangay Luyongbonbon of Opol, Misamis Oriental has submitted Barangay Ordinance No. 01, Series of 2023, to the Sangguniang Bayan of Opol for review;

WHEREAS, Barangay Ordinance No. 01, Series of 2023 is the collection of barangay clearance fee imposed on any business-related transactions in the barangay;

WHEREAS, pursuant to Section 48 of the Local Government Code, local legislative power shall be exercised by the sangguniang panlalawigan for the province; the sangguniang panlungsod for the city; the sangguniang bayan for the municipality; and the sangguniang barangay for the barangay;

WHEREAS, Section 447 (a) (1) (i) of the Code mandates the Sangguniang Bayan to approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and to review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, the Committee on Laws, Rules, Privileges and Human Rights has recommended the approval of the Barangay Ordinance No. 01, Series of 2023, of Barangay Luyongbonbon, Opol, Misamis Oriental;

WHEREAS, the Sangguniang Bayan concurs with the findings and recommendations of the Committee;

WHEREFORE, in a motion of Hon. Rhally Mae G. Piit and duly seconded by Hon. Roland B. Alfeche; it was

RESOLVED, AS IT IS HEREBY RESOLVED, to declare as valid Barangay Ordinance No. 01, Series of 2023, of Barangay Luyongbonbon, Opol, Misamis Oriental Entitled "An Ordinance on Collection of Corresponding Barangay Clearance Fee in the Application for any Business-Related Transactions".
