**Resolution No. 2023- 178**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MAYOR JAYFRANCIS D. BAGO, TO ISSUE A SPECIAL PERMIT TO THE POBLACION BARANGAY COUNCIL TO CONDUCT BINGO GAMES DURING THE ARAW NG POBLACION CELEBRATION ON JUNE 15, 2023**

**WHEREAS**, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code;

**WHEREAS**, Section 444 (b) (3) (v) of the Local Government Code allows the Municipal Mayor to issue permits, without need of approval therefor from any national agency, for the holding of activities for any charitable or welfare purpose, excluding prohibited games of chance or shows contrary to law, public policy and public morals;

**WHEREAS**, in a letter dated June 6, 2023, the Punong Barangay of Barangay Poblacion, Opol, Misamis Oriental, requested the Municipal Mayor, Atty. Jayfrancis D. Bago, for the conduct of Bingo Games during the Araw ng Poblacion Celebration on June 15, 2023;

**WHEREAS**, in an urgent letter dated June 9, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution authorizing him to issue a Special Permit to the Barangay Council of Barangay Poblacion, Opol, Misamis Oriental for the conduct of Bingo Games during the Araw ng Poblacion Celebration on June 15, 2023;

**WHEREFORE**, in a motion presented by Hon. Palmero F. Ebonia and duly seconded by Hon. Roland B. Alfeche; it was

**RESOLVED, AS IT IS HEREBY RESOLVED**, to approve the Resolution Authorizing the Local Chief Executive, Mayor Jayfrancis D. Bago, to issue a Special Permit to the Poblacion Barangay Council to conduct Bingo Games during the Araw ng Poblacion Celebration on June 15, 2023.


