**Resolution No. 2023- 195**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MAYOR JAYFRANCIS D. BAGO, TO GRANT FINANCIAL ASSISTANCE TO MR. JERRILITO C. TIJAP, A RESIDENT OF BARANGAY IGPIT, OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)**

**WHEREAS**, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code likewise provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

**WHEREAS**, the Medical Abstract dated June 16, 2023 shows that Mr. Jerrilito C. Tijap was diagnosed with Hypertensive Cardiovascular Disease, Bell's Palsy Left, Diabetes Mellitus Type 2, Dyslipidemia and was admitted on June 11, 2023 and discharged from Polymedic Medical Hospital on June 16, 2023;

**WHEREAS**, in an urgent letter dated June 16, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him to grant financial assistance amounting to Ten Thousand Pesos (PhP10,000.00) to Mr. Jerrilito C. Tijap, a resident of Barangay Igpit, Opol, Misamis Oriental;


**WHEREFORE**, in a motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Palmero F. Ebonia; it was


