Resolution No. 2023- 198

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE HOLCIM PHILIPPINES, INC., REPRESENTED BY ITS VICE PRESIDENT, FREDERIC VALLAT, FOR CO-PROCESSING OF THE SORTED MUNICIPAL SOLID WASTE IN THE MUNICIPALITY OF OPOL, MISAMIS ORIENTAL

WHEREAS, it is the policy of the State to adopt a systematic, comprehensive and ecological solid waste management program which shall ensure the protection of the public health and environment¹;

WHEREAS, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to the Code;

WHEREAS, the State shall ensure to retain the primary enforcement and responsibility of solid waste management with local government units while establishing a cooperative effort among the national government, other local government units, non- government organizations, and the private sector²;

WHEREAS, Section 444 (b) (1) (vi) of the Code mandates that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated June 23, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him to enter into a Memorandum of Agreement (MOA) with the Holcim

Philippines, Inc., represented by its Vice President, Frederic Vallat, for co-processing of the sorted solid waste in the Municipality of Opol, Misamis Oriental;


WHEREAS, the Holcim Philippines, Inc. has been certified by the Department of Environment and Natural Resources – Environment Management Bureau (DENR-EMB) as an entity capable of treating sorted solid waste of the municipality while producing cement in a single combined operation called co-processing;

WHEREFORE, in a motion presented by Hon. Jeffrey P. Pusan, and duly seconded by Hon. Eliezer A. Vacalares, Jr.; it was


