**Resolution No. 2023- 201**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT OFFICE, REPRESENTED BY ITS REGIONAL DIRECTOR, RAMEL F. JAMEN, FOR THE IMPLEMENTATION OF ASSISTANCE TO INDIVIDUALS AND FAMILIES IN CRISIS SITUATION (AICS) PROGRAM IN THE MUNICIPALITY OF OPOL**

**WHEREAS**, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated therein;

**WHEREAS**, pursuant to Section 17 (b) (2) (iv) of the Code, the local government units shall provide basic services and facilities such as, but not limited to, social welfare services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons; community-based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents, and victims of drug abuse; livelihood and other pro-poor projects; nutrition services; and family planning services;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code mandates that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated June 23, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD), represented by Regional Director Ramel F. Jamen, for the implementation of Assistance to Individuals and Families in Crisis Situation (AICS) Program in the Municipality of Opol;



**WHEREAS**, the DSWD and local government units are partners in the implementation of social services for the poor, vulnerable and marginalized sectors and there is a need for a Memorandum of Agreement (MOA) to ensure effective and efficient delivery of AICS to qualified beneficiaries;

**WHEREFORE**, in a motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Eliezer A. Vacalares, Jr.; it was


