Resolution No. 2023- 202

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MUNICIPAL MAYOR JAYFRANCIS D. BAGO, TO GRANT FINANCIAL ASSISTANCE TO MS. MAIDELINE D. CHUA, A RESIDENT OF BARANGAY MALANANG, OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)

WHEREAS, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 447 (a) (1) (iv) of the Code mandates the local government unit to adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events

WHEREAS, a Barangay Certification dated June 19, 2023 certified that Ms. Maideline D. Chua is a resident of Zone 2B, Malanang, Opol, Misamis Oriental and known to be a law-abiding citizen, is in good standing in the community and possessed of good moral character. It also states that she belongs to the indigent family and does not engage in any business nor have sufficient income to cover her family needs;

WHEREAS, the Local Disaster Risk Reduction and Management Office (LDRRMO), through Engr. Rommel C. Lonoy, issued a Certification dated June 22, 2023, stating that house of Ms. Maideline D. Chua was partially damaged by a tornado which transpired on June 9, 2023. The certification was issued to recommend for cash assistance amounting to Ten Thousand Pesos (PhP10,000.00);

WHEREAS, in an urgent letter dated June 23, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan to pass a Resolution authorizing him to grant Financial Assistance amounting to Ten Thousand Pesos (PhP10,000.00) to Ms. Maideline D. Chua, a resident of Barangay Malanang, Opol, Misamis Oriental;

WHEREFORE, in a motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Palmero F. Ebonia; it was




