**Resolution No. 2023-203**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MUNICIPAL MAYOR, JAYFRANCIS D. BAGO, TO GRANT FINANCIAL ASSISTANCE TO MR. GABBY D. DILLA, A RESIDENT OF BARANGAY BONBON, OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)**

**WHEREAS**, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code likewise provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

**WHEREAS**, a Certificate of Indigency dated May 29, 2023 certified that Mr. Gabby D. Dilla is a resident of Zone 5, Bonbon, Opol, Misamis Oriental and belongs to the indigent family;

**WHEREAS**, a Social Case Study Report dated June 2, 2023 showed that Mr. Gabby D. Dilla and her wife, Mrs. Mabel D. Travilla are both blind and asking for financial assistance for their transportation to Capiz where their family is living;

**WHEREAS**, in an urgent letter dated June 23, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan to pass a Resolution authorizing him to grant Financial Assistance amounting to Ten Thousand Pesos (PhP10,000.00) to Mr. Gabby D. Dilla, a resident of Barangay Bonbon, Opol, Misamis Oriental;

**WHEREFORE**, in a motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Jeffrey P. Pusan; it was




