Resolution No. 2023-205

A RESOLUTION ADOPTING RESOLUTION NO. 1, SERIES OF 2023, OF THE OFFICE OF THE LIGA NG MGA BARANGAY OF OPOL APPOINTING BARANGAY CAPTAIN NESTOR M. SAPIO, III AS THE TEMPORARY OIC-ABC FEDERATION PRESIDENT OF THE 21ST SANGGUNIANG BAYAN OF OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated therein;

WHEREAS, pursuant to Section 41 (b) of the Code, the regular members of the sangguniang panlalawigan, sangguniang panlungsod, and sangguniang bayan shall be elected by district, as may be provided for by law. Sangguniang barangay members shall be elected at large. The presidents of the leagues of sanggunian members of component cities and municipalities shall serve as ex officio members of the sangguniang panlalawigan concerned. The presidents of the "liga ng mga barangay and the pederasyon ng mga sangguniang kabataan" elected by their respective chapters, as provided in this Code, shall serve as ex officio members of the sangguniang panlalawigan, sangguniang panlungsod, and sangguniang bayan;

WHEREAS, under Section 446 (a) of the Code, the sangguniang bayan, the legislative body of the municipality, shall be composed of the municipal vice mayor as the presiding officer, the regular sanggunian members, the president of the municipal chapter of the liga ng mga barangay, the president of the pambayang pederasyon ng mga sangguniang kabataan, and the sectoral representatives, as members;

WHEREAS, in an urgent letter dated June 23, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan to pass a Resolution adopting Resolution No. 1, Series of 2023, issued by the Office of the Liga ng mga Barangay of Opol which appointed Punong Barangay Nestor M. Sapio, III as the Temporary OIC-ABC Federation President of the 21st Sangguniang Bayan of Opol, Misamis Oriental;

WHEREFORE, in a motion presented by Hon. Chizarina M. Ortigoza, and duly seconded by Hon. Roland B. Alfeche; it was


